

END-USER LICENSE AGREEMENT FOR SPECSYNC

Valid as of May 01, 2023

Spec Solution Kft's End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Spec Solutions Kft, for the Spec Solutions Kft software product identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and Spec Solutions Kft, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT.

The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.

1. GRANT OF LICENSE

The SOFTWARE PRODUCT is licensed as follows:

(a) Installation and Use

Licenser grants you the right to install and use copies of the SOFTWARE PRODUCT on your computer running a validly licensed copy of the operating system for which the SOFTWARE PRODUCT was designed.

(b) Backup Copies

You may also make copies of the SOFTWARE PRODUCT as may be necessary for backup and archival purposes.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS

(a) Maintenance of Copyright Notices

You must not remove or alter any copyright notices on any copies of the SOFTWARE PRODUCT.

(b) Distribution

You may not distribute registered copies of the SOFTWARE PRODUCT to third parties.

(c) Prohibition on Reverse Engineering, Decompiling, and Disassembly

You may not reverse engineer, decompile or disassemble the SOFTWARE PRODUCT, except

and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

(d) Rental

You may not rent, lease or lend the SOFTWARE PRODUCT.

(e) Support Services

Licensor may provide you with support services related to the SOFTWARE PRODUCT (“Support Services”). Any supplemental software code provided to you as part of the Support Services shall be considered part of the SOFTWARE PRODUCT and subject to the terms and conditions of this EULA.

(f) Optional Collection of Statistical Usage Data

In order to improve our services Spec Solutions Kft might collect statistical data about the usage on a voluntary basis. The collected data do not contain any personal or client-specific information or anything that would make the client identifiable. The statistical data collection can be disabled any time using the `--disableStats` command line option or the `toolSettings/disableStats` configuration option.

(g) Online Verification of License Usage

In order to verify the license usage of license customers Spec Solutions Kft might collect information about the license usage. The collected information includes: license ID, the number of synchronized scenarios, the hash computed from the username by irreversible calculation algorithm. The collected data allow Spec Solutions Kft to assess license usage but it is not possible to identify any personal data of the users.

(h) Compliance with Applicable Laws

You must comply with all applicable laws regarding use of the SOFTWARE PRODUCT.

3. TERMINATION

Without prejudice to any other rights, Licensor may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the SOFTWARE PRODUCT in your possession.

4. COPYRIGHT

All title, including but not limited to copyrights, in and to the SOFTWARE PRODUCT and any copies thereof are owned by the licensor or its suppliers. All title and intellectual property rights in and to the content which may be accessed through use of the SOFTWARE PRODUCT is the property of the respective content owner and may be protected by applicable copyright or

other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by the licensor.

The licenses of the used third party software (eg. open source) are included in the software package (third-party-licenses.txt).

5. NO WARRANTIES

The licensor expressly disclaims any warranty for the SOFTWARE PRODUCT. The SOFTWARE PRODUCT is provided 'As Is' without any express or implied warranty of any kind, including but not limited to any warranties of merchantability, non-infringement, or fitness of a particular purpose. The licensor does not warrant or assume responsibility for the accuracy or completeness of any information, text, graphics, links or other items contained within the SOFTWARE PRODUCT. The licensor makes no warranties respecting any harm that may be caused by the transmission of a computer virus, worm, time bomb, logic bomb, or other such computer program. The licensor further expressly disclaims any warranty or representation to Authorized Users or to any third party.

6. LIMITATION OF LIABILITY

In no event shall the licensor be liable for any damages (including, without limitation, lost profits, business interruption, or lost information) rising out of 'Authorized Users' use of or inability to use the SOFTWARE PRODUCT, even if the licensor has been advised of the possibility of such damages.
